### **CPF SIGNATURE PROJECT CONCEPT**

If you have been following CPF's work, you may recall that during the recent strategic planning process, one of the strategic objectives described in the five-year plan is to complete a signature project. We're excited to update you on the progress of our signature project. Through community conversations during the planning process, CPF gathered several possible project ideas. Over the last year, the Signature Project Committee developed preliminary plans for a short-list of projects for further review and evaluation. The CPF Board proposes to reconfigure CPF Gorge Trail hiking and bike access at the Buyea's Parking Lot entrance to better connect the trail from Albany Street and other village trails. Chittenango Creek is a blue-ribbon trout stream and an important natural feature worthy of protection that runs through the village center. Walkers, bikers, fishermen and -women, and nature lovers access CPF's Gorge Trail at this location. It's our mission to protect properties like this for the enjoyment of future generations. Gorge Trail There are three aspects of the project: 1) provide dedicated pedestrian/bike access from Albany Buvea's Street (Route 20) to the creekside green-space, 2) create designated trail parking and reroute the trail to more closely follow the creek; and 3) install pedestrian crosswalk and trail entrance at Williams Street. Upon completion, the trail and creek in the heart of the village will be much more visible and accessible, and the under-utilized green-space areas along the creek will be inviting and easy to use. **Enhance connectivity of Albany Street (Route 20) to** the Creekside Green-Space Section one of the project will create a dedicated pedestrian and bike pathway from Albany Street (Rt. 20) to the new trail parking area and creekside green space. This will improve the safety for walkers Cazenovia Creek and bikers and enhance the connectivity of Albany Street to the trail. CPF will install a gravel trail surface along the east side of

decorative physical barricade along the western edge of the new pedestrian area to delineate and differentiate pedestrian and vehicular traffic routes.

## Designated Trail Parking & Creekside Trail Reroute

For section two, CPF will reroute the trail to more closely follow creek contours from the parking lot. We will then add a defined trail parking area.

Visitors will be able to use amenities, including picnic tables and a kiosk. The kiosk will have maps and informative exhibits. A bench with an overhang to provide hikers shelter from the rain is a consideration. Future options include a trash receptacle, bike rack, and an EV charging station.

We will be seeking volunteers to help with overall clean-up and brush removal and to plant trees and shrubs. The new plantings will further define the trail while also screening the current view of the backs of the commercial buildings on the property and enhance the experience.

#### **Trail Entrance to Williams Street**

The final section of the project will be to add a crosswalk at the Williams Street trail entrance. The crosswalk will better define trail routing and provide safer crossing options for Burton Street student walkers and trail users.

We expect to break ground in 2021 on the Parking Area and Creekside Trail rerouting, with project completion expected in 2022, depending on project approvals. CPF is currently working to develop more detailed project cost estimates. We will be seeking grant funding and community contributions to support this critical project, so be on the lookout for opportunities to help either as a project volunteer or by making a financial contribution in support of the project.

The CPF Signature Project Committee and Committee Chair, David Beam, wish to thank the Cazenovia Area Community Development Association, Village of Cazenovia Mayor Kurt Wheeler, and the Buyea family for their assistance with this project.

#### Message From the E.D.

I am excited to be serving as CPF's Executive Director at such a momentous time for land conservation. The importance of the work that we do to preserve open space for public recreation has been unmistakably evident during the last 14 months since the onset of the COVID-19 pandemic.

If you're tuned in to conservation news, you have likely noticed that a lot is happening at both the state and national levels. In January of 2021, President Biden signed an executive order to protect at least 30 percent of our lands and inland waters and 30 percent of our ocean areas by 2030 (the 30x30 initiative). In April of 2021, the \$3 billion Restore Mother Nature Bond Act was included in the enacted 2021 New York State budget, and the measure will be placed on the November 2022 ballot. If approved, it will provide an unprecedented level of state funding to restore fish and wildlife habitats, preserve open space and enhance recreational opportunities, and prepare New York for the impacts of climate change. Importantly, we have also started to see a nationwide COVID-related shift in the places that people are choosing to live, as more of us are continuing to work remotely and choosing rural and suburban areas over cities, potentially placing greater development pressure on land in communities like Cazenovia.

The need for conservation now is great, but so are the potential opportunities. Together, we can work to preserve the historical, agricultural, and natural resources in and around Cazenovia for the benefit of us all.

#### **Under Construction**

#### Fairchild Parking Area Completed



The clearing of the utility right-of-way near the Fairchild Hill Trail Parking Area in April fast-tracked our planned 2021 trail parking area improvements. The upgraded trail parking area is open and ready for you, and we think that you'll agree it's a significant improvement! Many thanks to property owner Glen Trush for his work at the site and the Saturday morning work crew that braved the May 1st snow to help get the job done!

#### Willow Patch

Work on the Willow Patch began in 2020, with a targeted effort to remove vegetation from two large areas overgrown with the highly invasive plant Reynoutria japonica, commonly known as Japanese knotweed. The plant is very tenacious, and work to eradicate it from the Willow Patch continues this spring. CPF Board member and SUNY-ESF professor, Scott Shannon, is preparing a planting plan of native trees, shrubs, and perennials for installation on the slope at the base of Allen Street, one of the areas where knotweed removal is currently ongoing. This work is funded by the **Madison County Planning** Department through the Finger Lakes - Lake Ontario Watershed Protection Alliance (FLLOPA) Grant Program.

#### Kiosks – Fairchild (from Lorenzo/Meier's Creek Connector Trail) & Carpenter's Pond

CPF's Stewardship Committee is preparing for Summer 2021. Earlier this spring, stewardship volunteer Ken Reger reviewed all the CPF trail kiosks and prioritized two for replacement this summer: Carpenter's Pond and Fairchild Hill Trail (from Meier's Creek Brewery/Lorenzo entrance). The Kiosk Team will be making some minor cosmetic repairs to other kiosks throughout the season as well. ### **Grants & Projects**

#### NYS Conservation Partnership Program Grants

In early 2020, CPF was awarded two grants under the New York State Conservation Partnership Program and New York's Environmental Protection Fund (EPF). The New York State Conservation Partnership Program is administered by the Land Trust Alliance in coordination with the state Department of Environmental Conservation. Funds related to those grants, which were delayed due to COVID, have now been made available to CPF, and we have begun work on both projects.

One of these grants provides CPF with funding to upgrade our member database, develop a marketing and communications plan, and enhance our communications materials. We hired marketing expert Levi Spires in April 2021 to launch this project. Over the coming months, look for improved modern communication that will help us better connect with our members, reach a broader audience, and inform the Cazenovia community about our mission and activities.

CPF is also working on a project to survey and mark the boundaries of all CPF-owned properties. Delineated boundaries will benefit CPF as well as neighboring landowners when planning for property improvements.

#### A Note on Trail Etiquette

CPF's trails and trail parking areas are open from dawn to dusk to benefit the community. Unfortunately, our volunteers are reporting higher volumes of trash and pet waste discarded in parking lots and along the trails in recent months. Misuse of these facilities, including littering, overnight or after-hours parking, or disobeying posted parking instructions, may result in the temporary

or permanent closure of these areas. Please do your part to keep these areas open and in good condition for the enjoyment of all trail users. CPF trails and parking areas are packin/pack-out; please properly dispose of all your garbage and pet waste bags.

## The Nature Conservancy New York - Resilient & Connected Network Grant (TNC-NY RCN Grant)

CPF was recently awarded a capacity-building grant from The Nature Conservancy of NY. Over the last eight years, TNC has developed a map-based tool to identify lands of high conservation value for creating a connected network of lands to support climate-driven species migration. The award of this grant represents a fundamental shift in CPF's approach to conservation planning by providing the analytical tools needed to support a comprehensive approach to identifying essential areas for preservation within our service area.

The land conservation aspect of CPF's mission has always had implicit environmental benefits. This project provides CPF with the opportunity to more directly engage our community in

conversations about the essential ecological and climate-change mitigation benefits of land conservation.

In the coming weeks, CPF will be seeking to hire a part-time Conservation Planner with solid GIS skills and work experience in landscape planning, conservation, land stewardship, or similar fields.
