Conference to learn more about issues land trusts face

In the coming year, the Board will focus on developing and implementing necessary policy and procedural changes that will meet Land Trust Alliance (LTA) standards for accreditation. According to the LTA, the accreditation seal is a mark of distinction in land conservation. It recognizes organizations for meeting national standards for excellence, upholding the public trust, and ensuring that conservation efforts are permanent. Accreditation helps ensure maintenance of land trust tax-exempt status and securing grant funding. CPF will build on the recommendations that emerged from its LTA internal organizational assessment in 2008.

CPF remains committed to collaboration with other community and government groups.

Cazenovia is facing a number of demanding issues – ones that will have an impact on its future and its character. CPF remains involved in community-wide discussions to help preserve our historic places and landscapes. We are convinced that thoughtful, respectful dialogue among those with differing points of view is important to reaching suitable conclusions.

CPF's mission is to protect historic, agricultural, and natural resources in and around Cazenovia for the benefit of the community. We offer the public opportunities to use many miles of trail and engage in educational activities free of charge. Maintaining our trails, protecting our easements, and operating our programs require substantial funds, however. Since CPF receives no public funding, we rely on support from people in the community to continue current programs and provide additional activities. With that support, CPF can help ensure that the Cazenovia we love and enjoy now remains unique and attractive for generations to come.

## Leave a soft footprint, and please sign in

CPF is proud of its many trails and our trail stewards, staff and volunteers work hard to maintain them for safely and enjoyment. We encourage you to use them frequently. But....

Please...whenever you use the Gorge Trail, Fairchild Hill, or the Burlingame Trails, remember to sign in at the entrance. It is important to know the frequency with which trails are used so that we can manage them most effectively! The usage information is helpful, too, when applying for grant funding.

CPF trails are intended primarily for hikers, cross country skiers, and snowshoers. The local equestrian community may use the Burlingame Trails with permission only and during designated Limestone Creek Hunt events and the Lorenzo Driving Competition marathon. During those events, hikers should be cautious and all dogs must be on leash. Horseback riding is not permitted at all on the Gorge Trail.

Please respect the trails, offered for your enjoyment, honor trail etiquette, and protect the environment. We are fortunate to have such beautiful places to explore and appreciate. Let's keep it that way.

## Grant funding supports projects and activities

To supplement the generous contributions of our members and friends, CPF has applied for and been awarded a number of grants. Grant funding has been essential to a number of projects CPF has undertaken.

#### Central New York Community Foundation - \$4500

Restoring Wetland Function – April 2007-2009

The grant addressed restoring wetland function and creating public space in the Willow Patch. Stop by and enjoy the willow-defined seating areas off Mill Street.

#### Land Trust Alliance - \$8800

Capacity and Excellence – Stewardship Grant – June 2008

Funding supported the preparation of baseline documentation reports on easement properties. These reports are critical to the monitoring and enforcement of these easements in perpetuity.

#### Norcross Wildlife Foundation, Inc. - \$2000

August 2008

The grant supported the purchase of office and field technology equipment to support an easement monitoring and development program.

#### Upstate Institute Summer Field School - August 2008

The Institute sponsored a field school "fellow" to assist with easement baseline documentation, inspections, and other fieldwork.

#### September 2008

The grant funded a substantial guided internal organizational assessment of CPF. All board members participated in the detailed exercise.
